

OFFICERS' CERTIFICATE – COLLATERAL SUBSTITUTION

UIC Series 24E (Replacement of 810044)

The undersigned, Jason A. Berg, Chief Financial Officer of AMERCO, a Nevada corporation (the “Company”), hereby certifies to U. S. Bank National Association, as trustee under the U-Haul Investors Club Base Indenture dated as of February 14, 2011 (the “Base Indenture”), as follows. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Pledge Agreement (as hereinafter defined). This Certificate is provided pursuant to Section 6 of the Pledge Agreement.

1. Pursuant to Section 6 of the Pledge Agreement dated as of December 15, 2015 (“Pledge Agreement”), the property constituting Collateral under the Twenty-Seventh Supplemental Indenture dated as of December 15, 2015 to the Base Indenture (the “27th Supplement”) identified on Exhibit A hereto (the “Hazelton, PA Collateral”) is to be released from the Lien created pursuant to the Pledge Agreement, such release to be effective as of November 18, 2019 (such date, the “Date of Substitution”).

2. The property identified on Exhibit B hereto (“Replacement Collateral”) shall replace such Hazelton, PA Collateral, pursuant to Section 6 of the Pledge Agreement.

3. The Company has determined, in accordance with Section 6 of the Pledge Agreement, that the value of such Replacement Collateral is not less than the value of the Hazelton, PA Collateral as of the Date of Substitution.


4. As of the date hereof, and as of the Date of Substitution, no Event of Default exists.

5. Effective as of the Date of Substitution, Pledgor shall execute and deliver a recordable deed of trust on the Replacement Collateral.

6. I have read the conditions set forth in the Pledge Agreement and the 27th Supplement relating to the substitution of Collateral as contemplated herein, and all conditions thereto have been satisfied. In my opinion, I have made such examination and investigation as is necessary to enable me to express an informed opinion with respect thereto.


